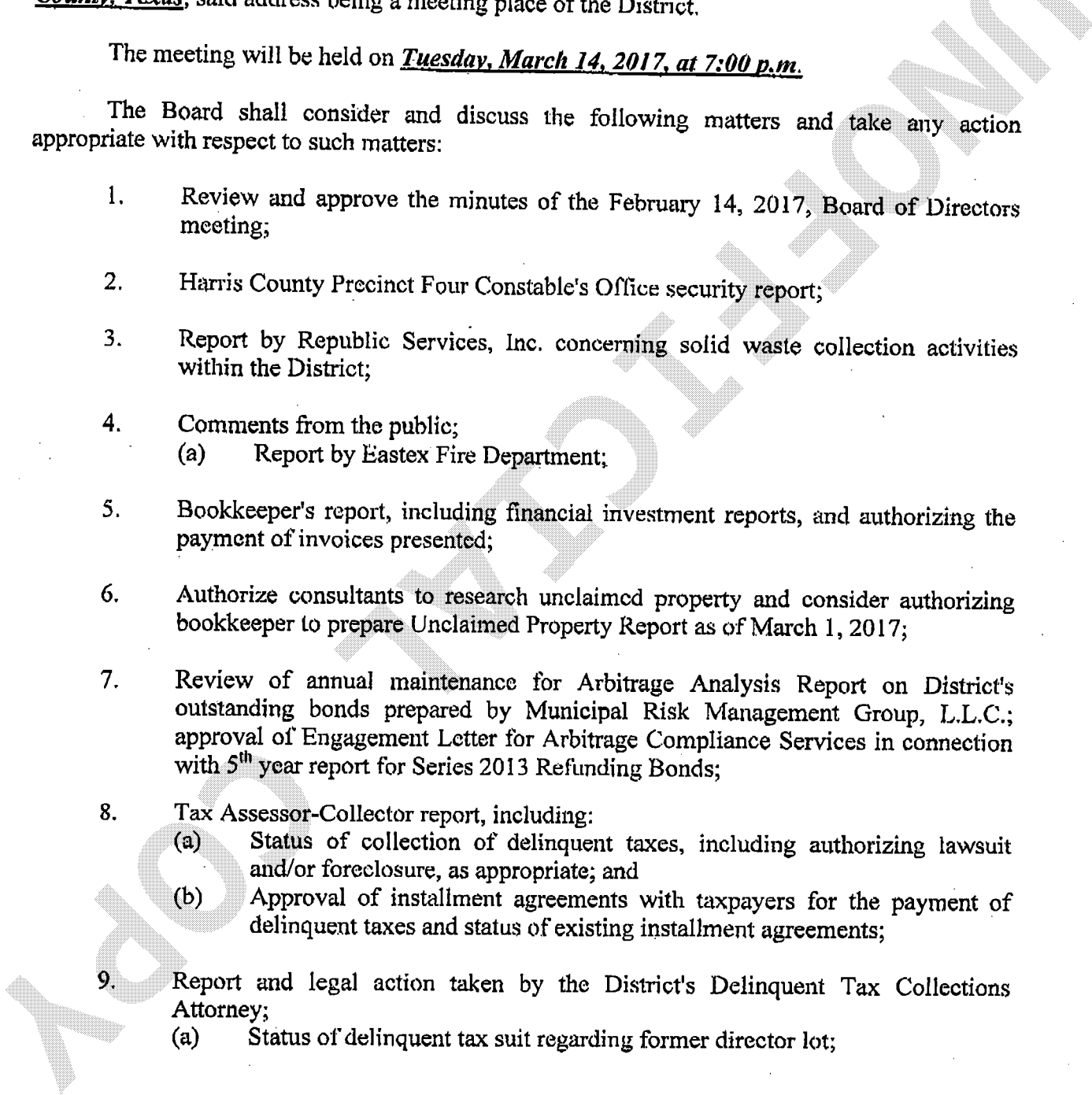
The meeting will be held on Tuesday, March 14, 2017, at 7:00 p.m.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Review and approve the minutes of the February 14, 2017, Board of Directors meeting;
2. Harris County Precinct Four Constable's Office security report;
3. Report by Republic Services, Inc. concerning solid waste collection activities within the District;
4. Comments from the public;
  - (a) Report by Eastex Fire Department;
5. Bookkeeper's report, including financial investment reports, and authorizing the payment of invoices presented;
6. Authorize consultants to research unclaimed property and consider authorizing bookkeeper to prepare Unclaimed Property Report as of March 1, 2017;
7. Review of annual maintenance for Arbitrage Analysis Report on District's outstanding bonds prepared by Municipal Risk Management Group, L.L.C.; approval of Engagement Letter for Arbitrage Compliance Services in connection with 5<sup>th</sup> year report for Series 2013 Refunding Bonds;
8. Tax Assessor-Collector report, including:

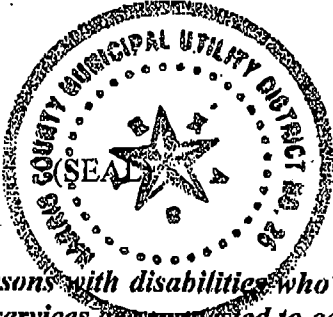

  - (c) Willowbend Apartments I, Ltd.;
    - i. Status of Consent to Encroachment and Indemnity Agreement concerning location of private utilities within District sanitary sewer easement;

  - (b) Conduct public hearing concerning Mo's violation of District's Rate Order and the imposition of penalties and fines; and
  - (c) Status update for compliance by landowner with various outstanding deficiency items;
19. Discussion regarding status of audit by the Internal Revenue Service of the District's Series 2005 Bonds;
20. Discuss potential establishment of website for District and related regulatory issues;
21. Discuss directors attendance at AWBD Summer Conference to be held in June;
22. Attorney's report;
23. Convene executive session in accordance with the Texas Open Meetings Act, including but not limited to consultation with attorney pursuant to Open Meetings Act, Section 551.071, Texas Government Code;

- 24. Reconvene in open session and authorize any necessary action resulting from executive session; and
- 25. Consideration of matters for possible placement on future agendas.
