
1. Pledge of Allegiance and invocation;

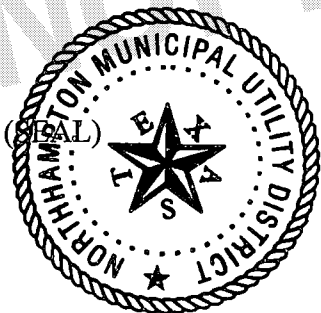
10. Status report on pending annexations, including AGG Box Solutions, LLC (1.613 acres);
