5. Receive Bookkeeper's report and approve invoices for payment.
6. Accept Annual Disclosure Statements from Investment Officer and Bookkeeper.
7. Conduct annual review of Investment Policy and Adopt Resolution Regarding Annual Review of Investment Policy.
8. Adopt Resolution Establishing the Authorized Depository Institutions and Adopting List of Qualified Broker/Dealers with Whom the District May Engage in Investment Transactions.
9. Conduct hearing on exclusion of certain land from District.
10. Enter findings of fact regarding exclusion hearing and adopt Order Excluding Certain Land.
11. Authorize execution of Amendment to Information Form.
12. Receive update from Community Development Committee
13. Receive update from Public Safety Committee
14. Receive update from Environmental & Beautification Committee .
15. Convene in Executive Session pursuant to Section 551.071, Texas Government Code, to conduct a Private consultation with attorney regarding pending or contemplated litigation and matters related to same.
