Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a regular public meeting at 323 East Louetta Road, Spring, Harris County, Texas 77373, said address being a meeting place of the District.

**The meeting will be held on Thursday, March 16, 2017, at 6:30 p.m.**

The Board shall consider and discuss the following matters and take any action necessary and appropriate with respect to such matters:

1. Minutes of the February 16, 2017, Board of Directors meeting;
2. Comments from the public;
3. Consider acceptance of resignation of Director Albright from Board of Directors and discuss appointment of a new Director to fill vacancy; authorize any action necessary and appropriate in connection therewith;
4. Consider presentation from representative of Community Assistance Department at Harris County Precinct 4 regarding road maintenance services;
5. District security issues;
6. Review and approve audit for fiscal year ended December 31, 2016;
7. Status of continuing disclosure report (due June 30, 2017);
8. Authorize attorney to file audit for fiscal year ended December 31, 2016 with Texas Comptroller of Public Accounts within 180 days of the fiscal year end in compliance with Section 140.008, Texas Local Government Code;
9. Tax Assessor-Collector's Report, including, authorizing the payment of invoices presented and approve transfer of accounts to uncollectible roll;
10. Report and legal action taken by the District's delinquent tax collections attorney, and take any action in connection therewith, including authorizing foreclosure proceedings, installment agreements, filing of proofs of claims, and termination of service to delinquent taxpayers;

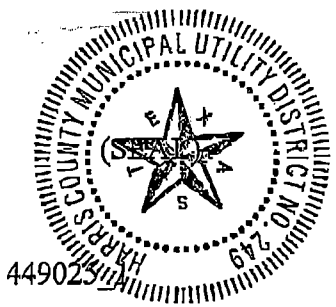
