## MEETING NOTICE AND AGENDA

Notice is hereby given that pursuant to V.C.T.A. Government Code Chapter 551, the Board of Directors of Sequoia Improvement District will meet in session, open to the public, on Monday March 13th, 2017 at 6:30 p.m. at 14435 Sequoia Bend Blvd., Houston, Texas inside the boundaries of the District, to consider and act upon the following matters:

1. Approve the minutes of the February 13<sup>th</sup>, 2017, Meeting.
2. Comments from members of the public. A speaker whose subject matter as submitted relates to an identifiable item of business on the agenda will be limited to three (3) minutes. A speaker whose subject matter is not on the agenda is limited to three (3) minutes if they have not appeared at any of the four preceding board meetings. A speaker whose subject matter is not related to an item of business on the agenda and who has appeared at any of the four preceding board meetings will be limited to one (1) minute. By state law, comments by the board members on any item not on the agenda shall be limited to: 1) Statements of specific factual information given in response to any inquiry; b) A recitation of existing policy in response to any inquiry; or c) A proposal to place the subject on the agenda for a future meeting.
3. Designation of Officers.
4. Authorize Continuing Disclosure
5. Rate Order.
6. Attorney/Engineers Reports
7. Take actions necessary for Sewer Rehab efforts.
8. Operators Report
9. Bookkeepers report. Review invoices and pay bills.
10. Tax collectors report, Approve requested payments.
11. Mail Delivery issues.
12. Water meter installation.
13. If during the course of the meeting covered by this notice, the Board should determine that a closed or executive session of the Board should be held or is required in relation to any agenda item included in this Notice, then such closed or executive meeting or session, as authorized by the Texas Open Meetings Act, will be held by the Board at the date, hour and place given in this notice concerning any and all subjects for any and all purposes permitted by Sections 551.071-555.084 of Texas Government Code and the Texas Open Meetings Act, including, but not limited to Section 551.071, for the purpose of a private conversation on any and all subjects or matters authorized by law.
