 - f. Lakewood Pines, Section 7, water, sewer, drainage and paving; and Lakewood Pines Drainage Channel, Phase 1;
 - g. Lakewood Pines, Sections 8, water, sewer, drainage;
 - h. Lakewood Pines, Sections 9, water, sewer, drainage; and
 - i. Lakewood Pines Boulevard extension, Phase 1.
10. Deeds, easements, consents to encroachment, requests for service or utility commitment letters.
11. Agreements for Financing Operation Expenses.
