The meeting will be held on **Tuesday, March 14, 2017, at 12:30 pm.**

The subject of the meeting will be as follows:

1. Review and approve the minutes of the February 14, 2017, Board of Directors meeting;
2. Consider report on and take appropriate action related to the status of collection of taxes, the status of collection of delinquent tax accounts, and the payment of related invoices;
3. Consider status of sales tax audit being performed by B&A Sales Tax Service;
4. Consider report on and take appropriate action related to the District's water, sanitary sewer and storm sewer systems, including review of customer billing, review of utility operations, repair and maintenance of District facilities, and consideration of customer appeals;
