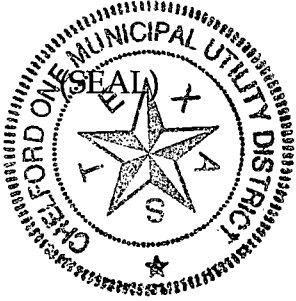
1. Approve minutes.
