CHELFORD ONE MUNICIPAL UTILITY DISTRICT

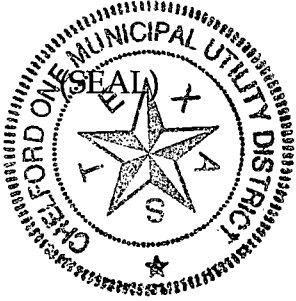

11. Report on Mission Bend Greenbelt Association meeting.
12. Renewal of District's insurance policies.
13. Financial and bookkeeping matters, including payment of the bills, review of investments, and adopt amended budget, if necessary.
14. Approve Annual Report and authorize filing of same in accordance with the District's Continuing Disclosure of Information Agreement and as required by SEC Rule 15c2-12.
