NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors ("Board") of the above captioned District will hold a public meeting at 1300 Post Oak Boulevard, Suite 1400, Houston, Harris County, Texas, said address being an office and meeting place of the District. The meeting will be held on Wednesday, April 19, 2017, at 10:30 a.m. The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Review and approve the minutes of the March 15, 2017, Board meeting;
2. Tax Assessor-Collector Report, including authorizing the payment of invoices presented, approving tax refunds and approving the moving of accounts to uncollectible roll;
3. Report and legal action taken by the District's delinquent tax collections attorney, including authorizing foreclosure proceedings, installment agreements, and the filing of proofs of claim;
4. Adoption of Resolution Authorizing an Additional Penalty on Delinquent Real Property Taxes and authorize the delinquent tax attorney to pursue the collection of delinquent real property taxes beginning July 1, 2017, including the filing of lawsuits, as necessary;
5. Bookkeeper's Report, including financial and investment reports;
6. Review and approve District's Audit Report for fiscal year ended December 31, 2016 (due May 15, 2017);
7. Review and approve Annual Financial and Operating (Continuing Disclosure) Report pursuant to SEC Rule 15c2-12, due June 30, 2017, and the adoption of a Resolution in connection with same;
8. Operations Report, including:
 - a) Status of repairs of District facilities;
 - b) Authorizing the repair and maintenance of District facilities and authorize acceptance of TEC Form 1295, as applicable, including:
 - (i) Repair of Clarifier No. 2 at Wastewater Treatment Plant by Neil Technical Services;
 - c) Appeals of District charges, refer accounts for collection and approve write-off of uncollectible accounts; and
 - d) Operator's annual report regarding status of the District's Identity Theft Prevention Program ("Program"), including discussion of Program compliance, staff training, effectiveness and suggested changes;
9. Status of filing water conservation plan annual implementation report with the North Fort Bend Water Authority;

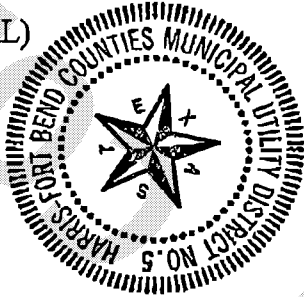

10. Authorize operator to prepare draft Consumer Confidence Report for review by Board of Directors;
11. Report from Champions Hydro-Lawn, Inc. regarding maintenance of District sites;
12. Engineer's report, and the taking of any action in connection therewith, including:
 - a) Authorizing the design and/or advertisement for bids for the construction of facilities within the District, and authorize acceptance of TEC Form 1295, and approving of related storm water plans;
 - (i) Construction of waterline interconnect loop on Saddlespur Lane to serve Marcel Plaza tract; and
 - (ii) Construction of waterline extension on Westheimer Parkway to serve EPC Stream Realty tract;
 - b) Authorizing the award of construction contracts or concurrence of award of contracts for the construction of facilities within the District, and authorize acceptance of TEC Form 1295, and approval of any related storm water permits;
