Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a public meeting at 17101 Nanes, Houston, Harris County, Texas, said address being an official meeting place of the District.

**The meeting will be held on Tuesday, April 18, 2017, at 6:30 p.m.**

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

- I. Approval of minutes of the March 21, 2017, Board of Directors meeting;

  - A. Tax Assessor-Collector
    1. Review status of collection of taxes and out-of-District payments, including delinquent out-of-District accounts;
    2. Disbursements from District's tax account;

    4. Adoption of Resolution Authorizing an Additional Penalty on Delinquent Real Property Taxes and authorize the Delinquent Tax Collections Attorney to pursue the collection of delinquent real property taxes beginning July 1, 2017, including the filing of lawsuits, as necessary;

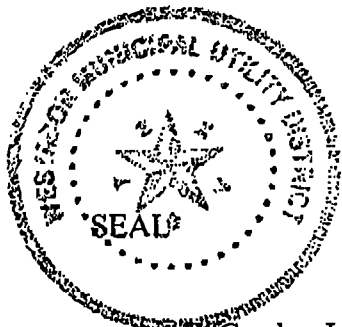
