The meeting will be held on Monday, April 17, 2017, at 12:00 Noon.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Review and approve minutes of the March 20, 2017, Board of Directors meeting;
2. Tax Assessor-Collector's Report, including authorizing the payment of invoices presented and approve moving of accounts to uncollectible roll;
3. Adoption of Resolution Authorizing an Additional Penalty on Delinquent Real Property Taxes and authorize the delinquent tax attorney to pursue the collection of delinquent real property taxes beginning July 1, 2015, including the filing of lawsuits, as necessary;
4. Delinquent tax collections attorney report, and take any action in connection therewith, including authorizing foreclosure proceedings, installment agreements, and the filing of proofs of claim
5. Bookkeeper's Report, including financial and investment reports and authorizing the payment of invoices presented;
6. Engineer's Report, including:
 - (a) Status of construction of facilities to serve the District;
 - (b) Approval and/or concurrence of any pay estimates and change orders; and
 - (c) Approval and execution of Consent to Encroachment and Indemnity Agreement by and between the District and KT Retail III, LLC;
7. Operator's Report, including:
 - (a) Monthly Report;
 - (b) Compliance with permits and regulatory requirements, including review of any notices of violations, responses to notices and remedial action taken, self-reporting forms as and if required, and correspondence to and from regulatory agencies regarding same;
 - (c) Appeals of District charges;
 - (d) Refer accounts for collection;
 - (e) Approve write-off of uncollectible accounts;
 - (f) Authorizing the repair and maintenance of District facilities;
 - (g) Authorize the preparation of a draft Consumer Confidence Report for review by Board of Directors; and
 - (h) Annual report regarding status of the District's Identity Theft Prevention Program ("Program"), including discussion of Program compliance, staff training, effectiveness and suggested changes;
