    - v. Riverstone Ranch, Section 9, water, sewer and drainage; and
    - vi. Riverstone Ranch at Clear Creek Lake F Part C Detention to serve Sections 8 and 9.
  - b. Bakers Landing projects (D.R. Horton), including:
    - i. detention pond to serve Bakers Landing; and
    - ii. water, sewer and drainage, Section 2A.
  - c. water, sanitary sewer, storm, and detention pond to serve KSTX Pearland Pkwy. Kroger.
6. Update on preparation of bond application no. 3.
7. Accept or convey deeds and easements and approve related Phase I environmental proposals, and consents to encroachment.
8. Accept Utility Deeds.
9. Approve Utility Conveyance and Security Agreements.

10. Services Agreement with operator for operation of District facilities.
11. Maintenance Agreements with homeowners and property owners associations regarding maintenance of District facilities.
12. Engineering services agreements for District facilities.
13. Annexation matters, including annexation requests, letter agreements and amendments thereto, annexation feasibility report, accept Petition for Addition of Land, authorize execution of Petition for Consent to Annex Land, Adopt Order Adding Land, accept Waiver of Special Appraisal, and Amendment to Information Form.
14. Financing and Reimbursement Agreements, including amendments and assignments thereto.
15. Report regarding development in the District.
16. Series 2017 Unlimited Tax Bonds, including:
  - a. disclosures pursuant to Municipal Securities Rulemaking Board requirements;
  - b. review bids and award sale of the District's \$5,000,000 Unlimited Tax Bonds, Series 2017;
  - c. adopt Resolution Authorizing the Issuance of the District's Unlimited Tax Bonds, Series 2017;
  - d. approve Paying Agent/Registrar Agreement;
  - e. approve Official Statement;
  - f. execution of Certificate Regarding Provision of Financial Advice;
  - g. authorize the Board of Directors to sign all documents relating to the bond sale and authorize attorney and financial advisor to take all necessary action to deliver bonds to the purchaser;
  - h. approve check to Attorney General relating to bond issue transcript review; and
  - i. execution of Amendment to Information Form.
