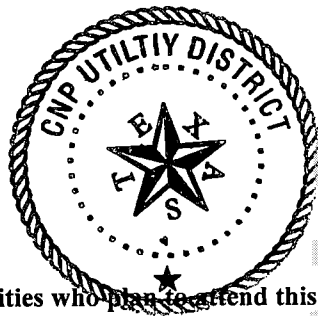
1. Consider comments from the public;
2. Review and consider approval of minutes of the March 23, 2017, Board of Directors meetings;
3. Consider status of security patrol of parks, and the taking of any actions required in connection therewith;
4. Consider report from Champions Hydro-Lawn regarding park maintenance and management, consider approval of maintenance, repair and/or installation of equipment facilities and/or grounds at park, including:
  - a) approval of Amended Contract with Champions for the maintenance of the Interstate Commerce Center detention pond, and the taking of any actions required in connection therewith;
5. Consider report on the status of collection of taxes, the status of collection of delinquent tax accounts, and the payment of invoices in connection therewith, and the taking of any actions required in connection therewith;
