  - c. review, revise and adopt Resolution Establishing the Authorized Depository Institutions and Adopting List of Qualified Broker/Dealers with Whom the District May Engage in Investment Transactions; and
  - d. Amendment to Agreement for Bookkeeping Services.

  - a. approve plans and specifications for District facilities, including detention facilities landscaping; and



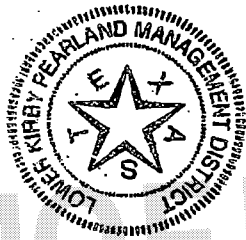

    - i. East Conveyance Pond (America Modern Green);
  - b. approve plans and specifications and authorize advertisement for bids for construction projects, including:
    - i. South Spectrum Boulevard from Promenade Drive west to Kirby Drive, including roadway, drainage and streetscaping (City of Pearland);
    - ii. SH 288 waterline extension (City of Pearland); and
    - iii. West Conveyance Pond;
  - c. review bids and award contracts, including:
    - i. Lower Kirby Regional Detention - East Conveyance Pond (America Modern Green); and
    - ii. Lower Kirby Regional Detention - South Detention Pond Phase 1;
  - d. approve pay estimates, change orders, and final acceptance, as appropriate, for construction projects, including:
    - i. Hooper Road Reconstruction and water, sewer, and drainage facilities within the right-of-way (City of Pearland);
    - ii. South Spectrum Boulevard from Promenade Drive east to existing South Spectrum Boulevard and Promenade Drive from future South Spectrum Boulevard south to termination point near District detention pond, including roadway, drainage, lighting, and streetscaping (America Modern Green);
    - iii. North Spectrum Boulevard traffic signal at Kirby Drive, including associated improvements (City of Pearland) and North Spectrum Boulevard east of Kirby Drive to Texas Department of Transportation, ditch, including roadway, drainage, lighting, and streetscaping (Spectrum 86 Partners);
