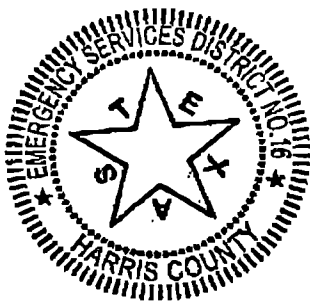
## MEETING NOTICE HARRIS COUNTY EMERGENCY SERVICES DISTRICT NO. 16

14. Receive reports from the Klein Volunteer Fire Department.
15. Review, discuss and take action regarding matters related to the construction of District Station No. 8.
