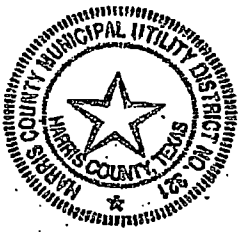
1. Approve minutes from prior meetings.
2. Financial and bookkeeping matters, including payment of the bills, review of investments, depository pledge agreements, and amendment of budget, if necessary.
3. Tax assessment and collections matters, including delinquent tax collections, installment agreements, payment of tax bills, and requests for estimates of taxable value.
4. Operation of District facilities, including billings, repairs, and maintenance.
5. Hearing on termination of water and sewer service to delinquent customers and for damages or theft of District facilities or services and authorize termination of service.
6. Conduct annual review and receive report from operator on Identity Theft Prevention Program and adopt Identity Theft Prevention Program Amendment.
7. Interlocal Agreement for Texas 811 membership.
8. Maintenance of detention ponds and District facility sites.
9. Development matters.
10. Engineering matters, including authorize design, approve plans and specifications, authorize advertisement for bids, review bids and award contracts, approve pay estimates and change orders, authorize final acceptance of projects, and direct engineer to notify insurance company, as appropriate, for the following:
 - a. Harris County MUD No. 321 Lift Station No. 1;
 - b. water, sewer, drainage, and paving for Ella Boulevard, Sections 2 and 3;
 - c. water, sewer, drainage, and paving for Pinto Business Park Drive;
 - d. water, sewer, drainage, and paving for Tall Pine Valley Drive;
 - e. water, sewer, drainage, and paving for Deer Trail Drive Extension;
 - f. next phase of District facilities;
 - g. proposals for engineering services;
 - h. deeds, easements, consents to encroachment, access agreements, pipeline crossing reimbursement and encroachment agreements, requests for service, utility commitment letters, and appraisals; and
 - i. update on bond application no. 4.

- 15. Reconvene in Open Session and authorize appropriate action regarding the offer of a financial or other incentive to a business prospect.
