**NOTICE OF PUBLIC MEETING**

Notice is hereby given to all interested members of the public that the Board of Directors ("Board") of the above captioned District will hold a public meeting at 16758 Telge Road, Cypress, Harris County, Texas 77429, said address being an office and meeting place of the District.

The meeting will be held on Monday, March 20, 2017, at 4:30 P.M.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Review and approval of the minutes of the February 20, 2017, Board meeting;
2. Tax Assessor-Collector report, including status of delinquent tax accounts and authorizing the payment of invoices presented, approving tax refunds and moving of accounts to uncollectible roll;
3. Report and legal action taken by the District's delinquent tax collections attorney, including authorizing foreclosure proceedings, installment agreements, the filing of proofs of claim and approval of turn-offs;
4. Bookkeeper's report, including financial and investment reports, authorizing the payment of invoices presented;
5. Operator's Report, including:
  - a) Authorizing the repair and maintenance of District facilities;
  - b) Appeals of District charges;
  - c) Refer accounts for collection; and
  - d) Approve write-off of uncollectible accounts;
6. Engineer's Report, including:
  - a) Authorizing the design, advertisement for bids and/or award of construction contracts or concurrence in the award of a contract for the construction of water, sanitary sewer and drainage facilities within the District, and authorize acceptance of TEC Form 1295, approval of any related storm water permits and approving of related storm water plans, including:
    - 1) Review and approval of any Storm Water Pollution Prevention Plans or Storm Water Quality Management Plans related to construction within or on behalf of the District, and the execution of any documentation in connection therewith;
  - b) Status of construction contracts, including the approval of any change orders and/or acceptance of facilities for operation and maintenance purposes, and authorize acceptance of TEC Form 1295 in connection therewith:
    - 1) Status of construction by Kenneth Lamb Construction Co., Ltd. of Water, Sanitary Sewer and Drainage facilities to serve Enclave at Longwood, Section 1;

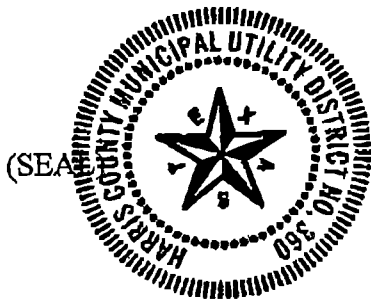

- 5) Status of expansion of Longwood Regional Detention Pond;
