Notice is hereby given that the Board of Directors of Grant Road Public Utility District of Harris County, Texas, will hold a regular meeting, open to the public, on **TUESDAY, April 18, 2017, at 10:30 am**, at 6363 Woodway, Suite 800, Houston, Texas, a meeting place of the District outside the District's boundaries, for the purposes of considering and acting upon the following matters:

 - (d) review proposal for renewal of Wastewater Treatment Plant Permit;
 - (e) authorize advertisement for bids, as necessary;
 - (f) approve pay estimates and change orders, as necessary;
7. Consider request for annexation of 2.91 acre tract, including:
 - (a) adopt Order Adding Land Subject to Certain Conditions;
 - (b) approve Petition for Addition of Certain Lands;
 - (c) approve Petition for Consent to Annex Land;
8. Developers' reports;
9. Attorney's report, including status of litigation with Texas Providence Investments;
10. Such other matters as may come before the Board.

If, during the course of the meeting covered by this Notice, the Board should determine that a closed or executive session of the Board should be held or is required in relation to any agenda item included in this Notice, then such closed or executive meeting or session, as authorized by the Texas Open Meetings Act, will be held by the Board at the date, hour, and place given in this Notice concerning any and all subjects for any and all purposes permitted by Sections 551.071-555.084 of Texas Government Code and the Texas Open Meetings Act, including, but not limited to Section 5.071, for the purpose of a private consultation with the Board's attorney on any and all subjects or matters authorized by law.

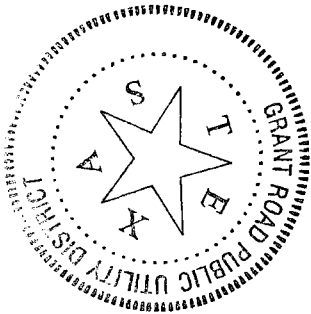
