Notice is hereby given that the Board of Directors of Grant Road Public Utility District of Harris County, Texas, will hold a regular meeting, open to the public, on **TUESDAY, April 18, 2017, at 10:30 am**, at 6363 Woodway, Suite 800, Houston, Texas, a meeting place of the District outside the District's boundaries, for the purposes of considering and acting upon the following matters:

7. Consider request for annexation of 2.91 acre tract, including:
  - (a) adopt Order Adding Land Subject to Certain Conditions;
  - (b) approve Petition for Addition of Certain Lands;
  - (c) approve Petition for Consent to Annex Land;
8. Developers' reports;
9. Attorney's report, including status of litigation with Texas Providence Investments;
10. Such other matters as may come before the Board.

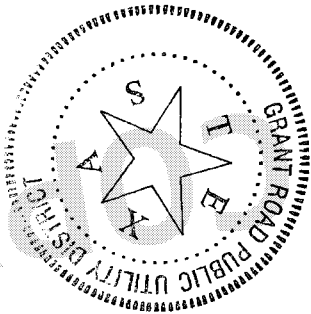
