The Board of Directors of Harris County Municipal Utility District No. 406 will hold a regular meeting on Tuesday, April 18, 2017, at 12:30 p.m., at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, Suite 2400, San Jacinto Room, Houston, Texas, to discuss and, if appropriate, act upon the following items:

1. Approve minutes from prior meetings.
2. Series 2017 Bonds, including:
  - a. review bids and award sale of the District's \$8,890,000 Unlimited Tax Bonds, Series 2017;
  - b. adopt Resolution Authorizing the Issuance of the District's \$8,890,000 Unlimited Tax Bonds, Series 2017;
  - c. approve Paying Agent/Registrar Agreement;
  - d. approve Official Statement;
  - e. execution of Certificate Regarding Provision of Financial Advice;
  - f. authorize the Board of Directors to sign all documents relating to the bond sale and authorize attorney and financial advisor to take all necessary action to deliver bonds to the purchaser;
  - g. approve check to Attorney General relating to bond issue transcript review;
  - h. execution of Amendment to Information Form; and
  - i. update from District engineer on Texas Commission on Environmental Quality inspection of facilities.
3. Financial and bookkeeping matters, including payment of the bills, review of investments, depository pledge agreements, and amendment of budget, if necessary.
4. Tax assessment and collections matters, including delinquent tax collections, installment agreements, depository pledge agreements, payment of tax bills, and requests for estimates of taxable value.
5. Operation of District facilities, including billings, repairs, and maintenance.
6. Hearing on termination of water and sewer service to delinquent customers and for damages or theft of District facilities or services and authorize termination of service.
7. Conduct annual review and receive report from operator on Identity Theft Prevention Program and adopt Identity Theft Prevention Program Amendment.
8. Interlocal Agreement for Texas 811 membership.
9. Maintenance of detention ponds and District facility sites.
10. Development matters.
11. Engineering matters, including authorize design, approve plans and specifications, authorize advertisement for bids, review bids and award contracts, approve pay estimates and change orders, authorize final acceptance

of projects, and direct engineer to notify insurance company, as appropriate, for the following:

- a. Harris County MUD No. 321 Lift Station No. 1;
  - b. Harris County MUD No. 406 Lift Station No. 2;
  - c. water, sewer, drainage, and paving for Ella Boulevard, Sections 2 and 3;
  - d. water, sewer, drainage, and paving for Pinto Business Park Drive;
  - e. water, sewer, drainage, and paving for Tall Pine Valley Drive;
  - f. water, sewer, drainage, and paving for Deer Trail Drive Extension;
  - g. traffic signal and paving improvements at Ella Boulevard and Beltway 8;
  - h. next phase of District facilities;
  - i. proposals for engineering services; and
  - j. deeds, easements, consents to encroachment, access agreements, pipeline crossing reimbursement and encroachment agreements, requests for service, utility commitment letters, and appraisals.
12. Capital budgets, letter financing agreements, collateral account agreements, site development agreements, and infrastructure work letter agreements.
  13. Meeting schedule and items for inclusion on next agenda.
  14. Convene in Executive Session pursuant to Section 551.087, Texas Government Code, to discuss or deliberate regarding the offer of a financial or other incentive to a business prospect.
  15. Reconvene in Open Session and authorize appropriate action regarding the offer of a financial or other incentive to a business prospect.
