

9. Discuss security patrol contract and approve all other matters relating thereto;
10. Attorney's report, including status of proposed annexation;
11. Such other matters as may come before the Board.

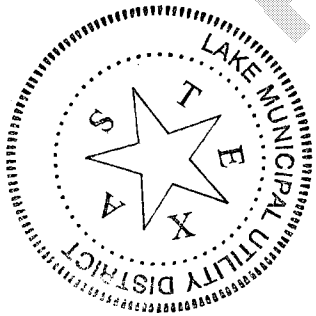
