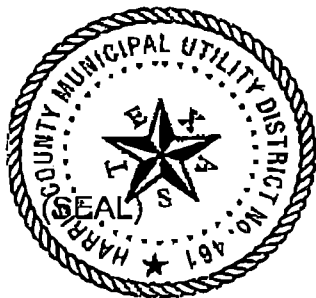

Notice is hereby given that the Board of Directors of Harris County Municipal Utility District No. 461 will hold a **regular** meeting, open to the public, on **WEDNESDAY, 19 APRIL 2017, at 11:30 a.m.**, at the offices of Coats Rose, P.C., **9 Greenway Plaza, Suite 1100**, Houston, Texas 77046; outside the boundaries of the District, to consider and act upon the following matters:

1. Minutes of the meeting of 15 March 2017;
2. Tax Assessor/Collector's Report, including approval of disbursements from the District's tax account;
3. Bookkeeper's Report, including approval of payments of the District's bills;
4. Old business, including:
  - (a) status of maintenance of the detention and mitigation basins, (Environmental Allies);
  - (b) response to letter to the City of Houston regarding water rate charged to the District;
  - (c) consider Assignment of Right to Reimbursement;
  - (d) consider Development and Financing Agreements for land proposed for annexation to the District;
5. New business, including:
  - (a) review Annual Financial Report for the District for the fiscal year ended 31 December 2016;
  - (b) authorize filing of the Annual Financial Report with the Texas Commission on Environmental Quality and other agencies as required;
  - (c) review investment policies and investment procedures of the District; adopt resolution evidencing annual review of the investment policies and investment procedures;
  - (d) status of operations under the District's Identity Theft Prevention Program; review of any "red flag" events; recommendation for any changes to the Program;
  - (e) consider proposed revisions to the rates for engineering services to the District;

- 6. Operator's Report, including:
  - (a) report on operations of the District's facilities; review of any maintenance and repair issues;
  - (b) review of water accountability;
  - (c) consider status of any unpaid accounts; authorize termination of services for unpaid accounts, if appropriate, pursuant to the requirements of the District's Consolidated Rate Order;
  - (d) status of Homeland Security Update to the Texas Commission on Environmental Quality;
- 7. Engineer's Report, including:
  - (a) approval of commitments for utility capacity as required;
  - (b) status of phase I mitigation repairs (P. M. S. Excavation);
  - (c) status of phase II mitigation repairs (Storm Maintenance and Monitoring, Inc.);
- 8. Developer's Report;
- 9. Attorney's Report, including:
  - (a) status of annexation of land into the District;
  - (b) U. S. Census of Governments;
  - (c) legislation affecting municipal utility districts;
- 10. Executive session, pursuant to Open Meetings Act, Section 551.071, Government Code, if desired by the Board; and
- 11. Action related to matters discussed during executive session;
- 12. Schedule future meetings as required; and
- 13. Discuss items to be placed on future meeting agendas;
