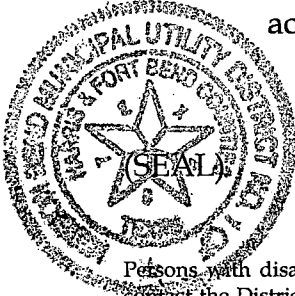

The Board of Directors of Mission Bend Municipal Utility District No. 1 will hold a regular meeting on **Monday, April 17, 2017, at 6:00 p.m.**, at the Chelford City Regional Wastewater Treatment Facility, 15027 Alief-Clodine Road, Houston, Texas 77082, to discuss and, if appropriate, act upon the following items:

1. Approve Minutes.
2. Public comments.
3. Authorize renewal of District's insurance policies, including review of engineer's list of District facilities to be insured.
4. Financial and bookkeeping matters, including payment of bills, review of investments, and budget comparison;
5. Tax assessment and collections matters, including delinquent tax collections, installment agreements, and payment of tax bills.
6. Operation of District facilities, including billings, repairs and maintenance, customer correspondence, meter replacement, and message language on water bills.
7. Hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
8. Amend Rate Order.
9. Approve engineer's report, including:
 - a. development within the District;
 - b. deeds and easements, consents to encroachment, requests for service, or utility commitment letters;
 - c. Mission Bend Integrated Water System;
 - d. Chelford City Regional Wastewater Treatment Facility matters;
 - e. GIS system; and
 - f. capital improvement projects, including review pay estimates and change orders with Cruz Tec, Inc. for the In-District sanitary sewer rehabilitation or with A.R. Turnkey for the offsite sanitary sewer to serve Greens at Brentford Apartments.
10. TCEQ Phase II Small MS4 General Permit, including status of compliance, necessary training, and public comment.
11. West Harris County Regional Water Authority.
12. Reports from Directors and District consultants regarding events and activities attended during the month.
