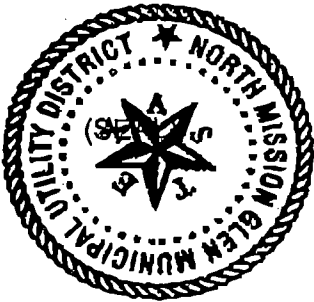

1. Comments and questions from District residents;
2. Approval of minutes of the meeting of 14 February 2017;
3. Bookkeeper's Report, including:
 - (a) authorize payment of the bills of the District;
 - (b) review investments of the District's funds;
 - (c) status of Depository Pledge Agreement with Cadence Bank;
4. Tax Assessor/Collector's Report, including:
 - (a) approve payments from the District's tax account;
 - (b) approve actions regarding collection of delinquent taxes, penalties, and interest; consider termination of services for nonpayment of amounts due to the District;
5. Old business, including review of the activities of the North Fort Bend Water Authority;
6. New business, including:
 - (a) discuss status of residential solid waste contract with Waste Corporation of Texas, LP (WCA); take any necessary action; (contract expires 31 July 2017; notice of cancellation required by 31 May 2017);
 - (b) review and discuss residential solid waste collection proposals; take any necessary action;
7. Operator's Report, including:
 - (a) report on repairs and operations of the District's facilities;
 - (b) status of work approved by the Board;
 - (c) termination of services to accounts delinquent in the payment of invoices from the District; adjustments to customer accounts;
 - (d) report on amounts back charged on behalf of the District;
 - (e) report on status of filing of Annual Homeland Security Contact Update with Texas Commission on Environmental Quality (due 28 February 2017);
 - (f) report on status of annual emergency preparedness training;
 - (g) report on status of Texas Water Development Board Survey of Ground and Surface Water Use (due 31 March 2017);

 - (a) review updated list of priority upgrades to the District's facilities, including pricing and prioritization, and authorize any necessary action;
 - (b) status of 53 residential unit development at Riverside Drive;
 - (c) status of library development by Fort Bend County in the District;
 - (h) status of preparation of application for renewal of District's wastewater permit with Texas Commission on Environmental Quality (expires 1 September 2017);
 - (d) status of filing of MS4 Annual Report for Year 3 (due to Texas Commission on Environmental Quality 13 March 2017);
 - (e) discuss proposed Five-Year Plan and Cost Summary relating to improvements to the District's Water Plant; take any necessary action;
