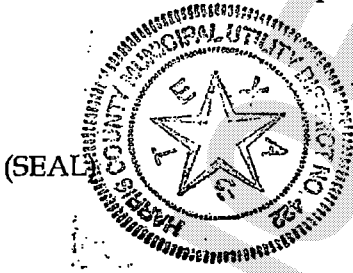
**NOTICE OF MEETING**

3. Tax assessment and collections matters, including delinquent tax collections, installment agreements, and payment of tax bills.
4. Operator's report.
5. Adopt Order Adopting Identity Theft Prevention Program.
6. Approve annual report on implementation of Water Conservation Plan.
7. Detention pond maintenance, including:
  - a. adopt Resolution Establishing Rules and Regulations Regarding Use of Detention Ponds.
8. Engineering matters, including preparation of plans and specifications, approval of plans and specifications, advertisement for bids, bid review, contract award, Pay Estimates and Change Orders, and acceptance of projects, if appropriate, for the following:
  - a. water, sewer, and drainage facilities to serve Lakewood Pines, Section 2;
  - b. Regional Lift Station & Force Main;
  - c. Regional Wastewater Treatment Plant;
  - d. stormwater quality pond maintenance;
  - e. Lakewood Pines, Phase 3, clearing, grubbing and grading;
  - f. Lakewood Pines, Section 7, water, sewer, drainage and paving; and Lakewood Pines Drainage Channel; Phase 1;
  - g. Lakewood Pines, Sections 8, water, sewer, drainage;
  - h. Lakewood Pines, Sections 9, water, sewer, drainage; and
  - i. Lakewood Pines Boulevard extension, Phase 1.
9. Deeds, easements, consents to encroachment, requests for service or utility commitment letters.
10. Receive report on development in the District.
