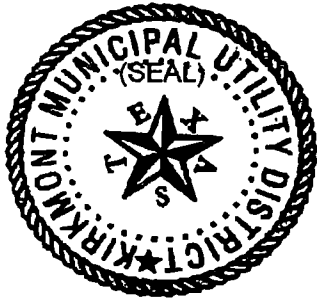

  - k) Such other documents and certificates necessary to obtain approval of the Bonds by the Attorney General of Texas;
