The District will consider and act upon the following matters:

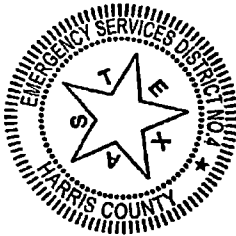
1. Call to Order.
