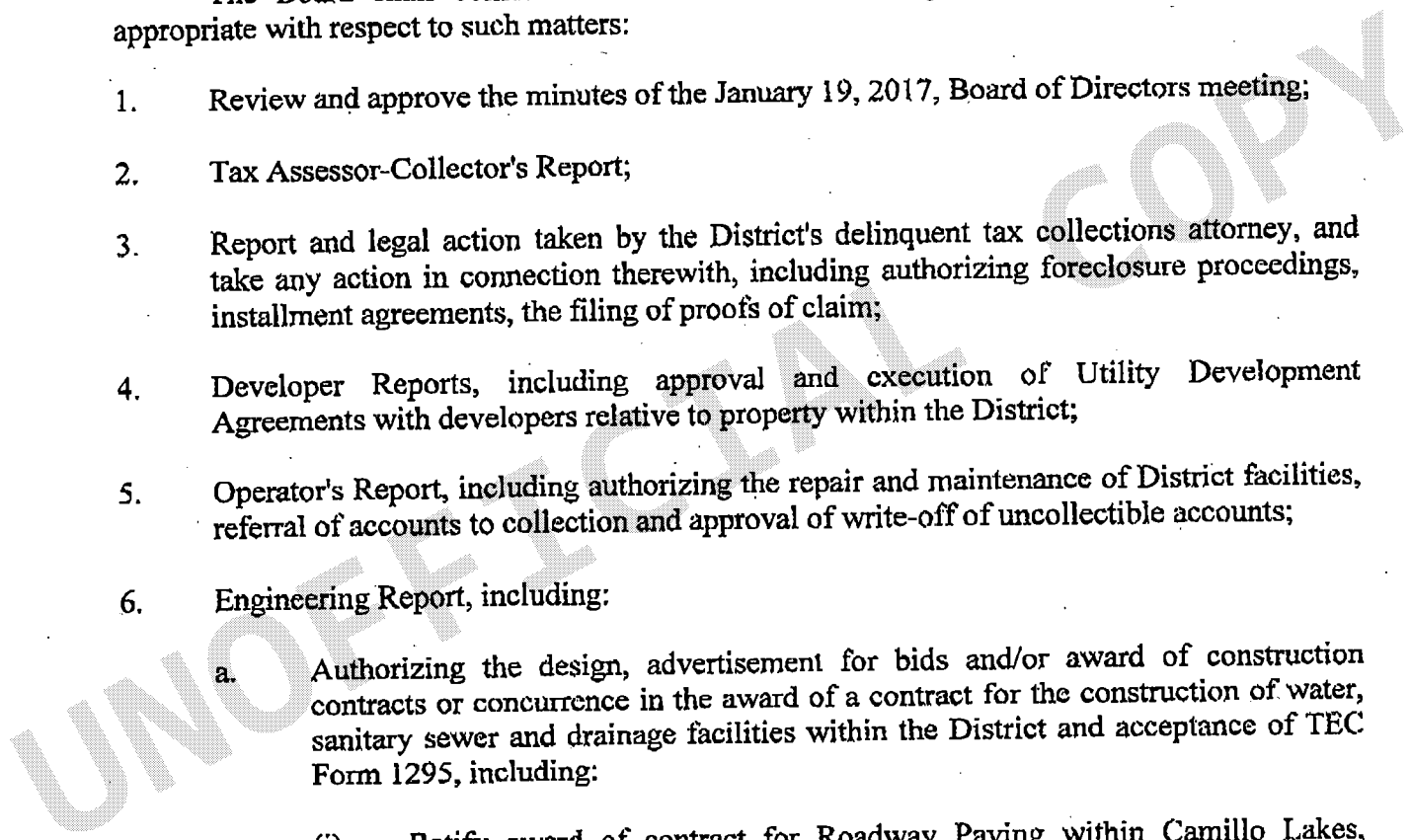
**NOTICE OF PUBLIC MEETING**

Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a regular public meeting at 1300 Post Oak Boulevard, Suite 1400, Houston, Harris County, Texas 77056, said address being an office and meeting place of the District.

The meeting will be held on Thursday, March 16, 2017, at 12:00 noon.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Review and approve the minutes of the January 19, 2017, Board of Directors meeting;
2. Tax Assessor-Collector's Report;
3. Report and legal action taken by the District's delinquent tax collections attorney, and take any action in connection therewith, including authorizing foreclosure proceedings, installment agreements, the filing of proofs of claim;
4. Developer Reports, including approval and execution of Utility Development Agreements with developers relative to property within the District;
5. Operator's Report, including authorizing the repair and maintenance of District facilities, referral of accounts to collection and approval of write-off of uncollectible accounts;
