1. Hear from the public.

3. Hear update on park facilities and consider acting thereon.
4. Receive Bookkeeper's Report, authorize payment of the District's bills, review and approve investment report and consider taking any other necessary action requested by Bookkeeper.
5. Receive Tax Assessor/Collector's Report, authorize payment of checks from Tax Account, and consider taking any other action requested by Tax Assessor/Collector.

  - b. Amend Rate Order.
7. Receive Engineer's Report, approve report, pay estimates and change orders, and consider taking any other necessary action requested by Engineer.
8. Receive Attorney's Report and consider acting thereon, including:
  - a. Adopt Resolution Evidencing Review of Identity Theft Prevention Policy; and
  - b. Discuss and consider taking action regarding graywater irrigation system and SWIFT application.
