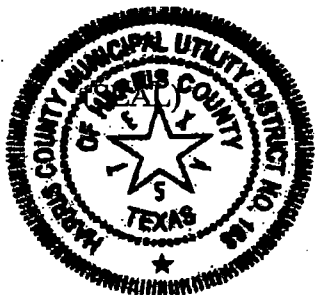

NOTICE OF REGULAR MEETING

TO: THE BOARD OF DIRECTORS OF HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 168  
OF HARRIS COUNTY, TEXAS, AND TO ALL OTHER INTERESTED PERSONS:

Notice is hereby given that the Board of Directors of Harris County Municipal Utility District No. 168 of Harris County, Texas (the "District") will hold a regular meeting on **Tuesday, March 14, 2017**, at 6:00 p.m., at the District Office, 9818 Paddock Court, Houston, Texas 77065, inside the boundaries of the District, open to the public, to consider and act upon the following matters:

1. **Public Comments:** Receive comments from the public. (5 minute limit per speaker for comments made during this meeting)
2. **Minutes:** Approve minutes of the previous meeting(s).
3. **Action List:** Review action list, and authorize appropriate action.
4. **Security:** Receive Security Report, and authorize appropriate action.
5. **Tax Assessor/Collector:** Approve Tax Assessor/Collector's report, approve payment of bills, and authorize appropriate action.
6. **Delinquent Tax Attorney:** Receive report from the Delinquent Tax Attorney, and authorize appropriate action.
7. **Bookkeeper:** Approve Bookkeeper's report, investment report, and payment of bills, and authorize appropriate action.
8. **Secondary Disclosure:** Approve and authorize filing of secondary disclosure report as required by SEC Rule 15c2-12.
9. **Investment Issues:** Consider and approve amending the District's Investment Policy, approve a Resolution Adopting an Amended Investment Policy; adopt a resolution setting forth the new broker/dealer list; and authorize all appropriate action.
10. **Operator:** Approve Operator's report, and authorize appropriate action on the following:
  - a. **M&R Report.** Receive the Maintenance and Repair Report.
  - b. **Annual Reports.** Consider and approve annual Water Loss Audit and authorize preparation of annual Water Conservation Implementation Report.
  - c. **Chlorine and Bacteriological Reports.** Receive report on chlorine levels and bacteriological test results.
  - d. **STP.** Receive report on and consider Steeplechase Joint Venture Sewage Treatment Plant matters.
  - e. **Utility Termination.** Receive report on termination of utility services to customers and delinquent accounts.
11. **NHCRWA:** Receive report on the status of the activities of the North Harris County Regional Water Authority ("NHCRWA"), and authorize appropriate action.
12. **Rate Order:** Consider amending the District's Rate Order, and authorize appropriate action.
13. **Engineer's Report:** Approve Engineer's report and consider and authorize appropriate action regarding engineering matters affecting the District, including, but not limited to, the following:
  - a. **Conversion of Water Well No. 3.** Receive report on the progress of construction; approve Pay Estimate(s) and Change Order(s), if any, and Certificate of Completion.
  - b. **HCMUD 170 Regional Wastewater Treatment Plant.** Receive report on the progress of construction of Phase II improvements; concur with Pay Estimate(s) and Change Order(s), if any, and Certificate of Completion.
  - c. **Utility Reservation.** Consider and approve request for utility reservation, if necessary.
14. **Bond Issue:** Receive update on Series 2017 bond issue, and authorize appropriate action.

- 15. **Tablets for Directors:** Consider and adopt Resolution regarding use of tablets by Directors, and authorize appropriate action.
- 16. **Park Signage:** Receive report on installation of signage at the parks, and authorize appropriate action.
- 17. **Landscaping Maintenance:** Receive report on status of landscaping issues along Eldridge Parkway, and authorize appropriate action.
- 18. **Executive Session:** Convene executive session to: (a) consult with the District's attorney in accordance with Section 551.071 of the Texas Government Code; (b) discuss acquisition of real property in accordance with Section 551.072 of the Texas Government Code; or (c) discuss deployment or implementation of security personnel or devices in accordance with Section 551.075 of the Texas Government Code.
- 19. **Reconvene in Open Session:** Reconvene in public session to take action with respect to (a) legal issue discussed, (b) acquisition of real property or (c) deployment or implementation of security personnel or devices.
