

  - c. authorize Tax Assessor and Collector to move uncollectible delinquent personal property accounts to uncollectible tax roll.
  - d. authorize filing of suit to foreclose tax lien on delinquent accounts.
  - e. authorize termination of water service to accounts with delinquent taxes.
