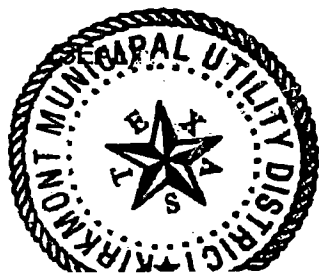
# NOTICE OF MEETING KIRKMONT MUNICIPAL UTILITY DISTRICT OF HARRIS COUNTY, TEXAS
