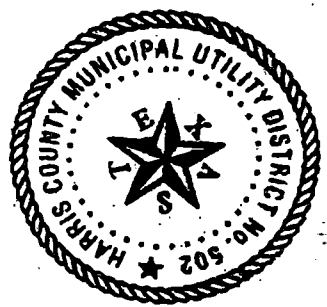
NOTICE OF PUBLIC MEETING
