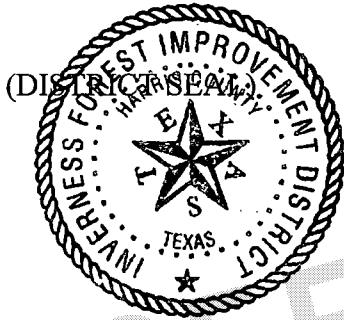
1. Public comments;

4. Security Report;
5. Approve audit report for the fiscal year ending December 31, 2016, and authorize filing of same;
6. Authorize preparation and filing of continuing disclosure materials;
7. Developer's Report, including:
  - a. Inverness Road Industrial Park;
  - b. Vigavi Realty;
  - c. Stratton Development & Construction ("Stratton") 4-acre tract site at 1302 Bammel;
  - d. Stratton 5.47-acre tract at southwest corner Greenbrook and FM 1960, including Stratton's request for reimbursement for construction of water, sewer and drainage facilities;

  - f. 1.5067-acre tract located at Kenchester Drive;
