After conducting a reasonable inquiry, Merck has been unable to identify any affiliation or business relationship that it has directly with persons who are either local government officers of Harris County Hospital District or who appoint or employ a local government officer of Harris County Hospital District for which it understands disclosure to be required. Merck has based its response to this question on the list of local government officers and the list of individuals who appoint or employ the local government officers that were provided to Merck by Harris County Hospital District. Merck does have an existing contract with the Harris County Hospital District and thus has business relationships with employees of the Hospital District for the purpose of performing its obligations under that contract.

Despite diligent efforts to obtain the information by Merck, Harris County Hospital District has been unable to provide Merck with a list of corporations or other business entities for which the local government officers of Harris County Hospital District serve as an officer or director, or hold an ownership interest of 10 percent or more. Accordingly, Merck is unable to answer this question with respect to such affiliations or relationships.
