14. To meet in Closed Session pursuant to Government Code §551.074 to discuss personnel matters.

16. Review and take action on District real estate matters and personnel matters.
17. Discuss any new items which need to be on the agenda for the subsequent District meetings including the regular District meeting set for April 17, 2023.
