Notice is hereby given that the Board of Directors of Harris County Municipal Utility District No. 387 will hold a regular meeting on Wednesday, May 25, 2022, at 4:45 p.m., at 2455 Lake Robbins Drive, The Woodlands, Montgomery County, Texas, said address being a meeting place of the District. The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

- 1. Public comments;
- 2. Minutes of the April 27, 2022, meeting of the Board of Directors;
- 3. Acceptance of Qualification Statements, Bonds, Oaths of Office and Affidavits of Current Director for Directors Duhs and Phillips;
- 4. Elections Not to Disclose Certain Information;
- 5. Election of officers of Board of Directors;
- 6. Approval of District Registration Form relative to election of Directors;
- 7. Authorize preparation and maintenance of a local government officers list in connection with conflict of interest disclosure requirements;
- Bookkeeping and investment reports, including authorize the payment of invoices and charges incurred by the District, and adopt any resolution(s) regarding the investment of District funds;
- Operator's report, including, repair and maintenance of District facilities;
- 10. Engineer's report, including:
 - i) Status of TPDES permit renewal for wastewater treatment plant;
 - ii) Preventative maintenance items, including:
 - a) Wastewater treatment plant inspection program;
 - b) Water plant inspection program; and
 - c) Sanitary sewer line and manhole inspection;
 - iii) Authorize the design, advertisement for bids and/or award of construction contracts or concurrence in the award of a contract for the construction of water, sanitary sewer and drainage facilities within the District, and authorize acceptance of TEC Form 1295;
 - iv) Status of construction contracts, including the approval of any change orders, and acceptance of TEC Form 1295 in connection therewith, and/or acceptance of facilities for operation and maintenance purposes, including:

- a) FEMA flood hazard mitigation projects (Neil Technical Services Corp.);
- b) Water Plant No. 3 GST No. 2 Rehabilitation Project (2021); and
- c) Sanitary Sewer Line and Manhole Inspection (2021);
- v) Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District; and
- vi) Rehabilitation and/or replacement of wastewater treatment plant;
- 11. Developer's report, including authorizing design, advertisement for bids or construction contracts for certain water, sewer and drainage facilities on behalf of the District;
- 12. Attorney's report;
- 13. Recess in Executive Session pursuant to §551.071 Texas Government Code to discuss:
 - i) Purchase of Phases III and IV of leased wastewater treatment plant facilities from AUC Group, L.P.; and
 - ii) Construction activity by Harris County adjacent to wastewater treatment plant site;
- 14. Reconvene in open session and authorize any necessary action resulting from executive session;

15. Matters for possible placement on future agendas.
