CINCO MUNICIPAL UTILITY DISTRICT NO. 6



1. Operations and service requirements relating to COVID-19 epidemic and ratification of any emergency actions, if necessary.
2. Approve minutes.
3. Public comments.
4. Financial and bookkeeping matters, including payment of the bills, review of investments, and amend budget, if appropriate.
5. Tax assessment and collections matters, including payment of bills, delinquent tax attorney matters, status of delinquent accounts, and settlement options.

8. Operation of District facilities, including:
 - a. billings, maintenance and repairs to District facilities;

 - d. conduct annual review and receive report from operator on Identity Theft Prevention Program.
9. Hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
10. Phase II Small MS4 General Permit and Storm Water Management Plan.
11. Report on North Fort Bend Water Authority matters, including Larry's Toolbox Water Conservation Program.
12. Homeowners Association matters, including participation in community projects and authorize appropriate action, including:
 - a. Cost and Maintenance Agreement with Kelliwood Fund, Inc. for irrigation system upgrades.
13. Discuss Cinco Municipal Utility District No. 5 Esplanade Restoration Project and authorize appropriate action, including approve First Amendment to Interlocal Contribution Agreement.
14. Engineering matters, including update on America's Water Infrastructure Act Risk and Resilience Assessment and Emergency response Plan.
15. District website matters.


