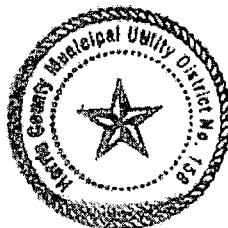
### NOTICE OF PUBLIC MEETING

Members of the public may access the meeting by following the instructions listed at the bottom of this notice.

The meeting will be held at **10:00 a.m. on Friday, April 16, 2021.**

The subject of the meeting is to consider and act on the following:

1. Public comment
2. Approve minutes of March 19, 2021 meeting
3. Tax assessor-collector's report; status of tax collections
4. Delinquent taxes; authorize termination of water service as appropriate; authorize litigation and installment agreements
5. Operator's report; customer correspondence; status of operation of District facilities; repairs and maintenance of District facilities, termination of service to delinquent accounts
6. City of Houston water and sewer rate increase; adjustment of District water and sewer rates
7. Detention pond operations report; authorize pond repairs and maintenance
8. Engineer's report; authorize preparation of plans as appropriate; authorize advertising for receipt of bids as appropriate; award contracts; approve change orders
9. Bookkeeper's report; pay bills and investment of District funds
10. Financial Advisor's report; status of financing projects and options for refinancing District debt

Instructions for accessing video/telephone conference call:

On March 16, 2020, in accordance with section 418.016 of the Texas Government Code, Governor Abbott has suspended various provisions of the Texas Open Meetings Act that require government officials and members of the public to be physically present at a specified meeting location (the "Proclamation"). In accordance with the Proclamation, the District has implemented procedures to allow members of the public to participate and address the Board of Directors during the telephone conference meeting. To participate in the telephone conference meeting:

3. All participants have the option of joining the meeting by phone (audio portion only) or also joining the meeting by video conference using a computer or other internet capable device. If you are trying to join the video conference via mobile device or tablet, you may need to download the Microsoft Teams mobile application. Use the phone number and conference ID reflected above to participate in the meeting via conference call. If you cannot hear the meeting on your computer, you may also need to call in to the telephone conference to listen to the meeting. All public participants will automatically be placed in the "Listen Only" mode. During the Public Comment portion of the meeting, participants may unmute their line by pressing \*6 to make a comment.
