
② The Board of Directors of Harris County Municipal Utility District No. 6 will hold a regular meeting on Tuesday, June 15, 2021, at 6:00 p.m., at 8303 West Road, Houston, Texas, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Minutes.
3. Agreement with Westbank Homeowners Association for Security Services.
4. Discuss garbage collection matters and authorize appropriate action.
5. Authorize delinquent tax attorney to proceed with collection of delinquent taxes.
6. Tax assessment and collections matters, including delinquent tax collections, installment agreements, and payment of bills.
7. Financial and bookkeeping matters, including payment of the bills and review of investments.
8. Operation of District facilities, billings, repairs, and maintenance.
9. Hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
10. Engineering matters, including:
 - a. preparation and approval of plans and specifications, advertisement for bids, award of construction contracts, approve proposals, pay estimates, change orders, and final acceptance and direct engineer to notify insurance company of new facility for the following:
 - i. integration of GIS maps for water and sanitary sewer;
 - ii. rehabilitation of wet well and manhole;
 - iii. park, including approve design proposal, construction budget, and maintenance budget;
 - b. consider requests for annexation or out of District service, including approve out-of-district service agreement and accept acknowledgment of out-of-district service agreement assignment; and
 - c. other engineering matters.
11. Approve the Risk and Resilience Assessment and authorize filing of the Certification of the Risk and Resilience Assessment with the Environmental Protection Agency.

12. If necessary, Convene Executive Session pursuant to Chapter 551.076, Texas Government Code, to deliberate a security audit, including the Risk and Resilience Assessment.
13. Re-convene in Open Session and authorize appropriate action regarding the security audit, including the Risk and Resilience Assessment.
