 - d. easements, deeds, plats, consents to encroachment, requests for service or utility commitment letters.
10. Maintenance of District facilities, including:
 - a. update on maintenance of Vintage Royale Detention Pond and Vintage Royale Amenity Pond, including proposals for maintenance; and
 - b. update on maintenance of regional detention pond.
11. Update on park and recreation facility projects, including:
 - a. construction and maintenance of landscaping and irrigation in the District;
