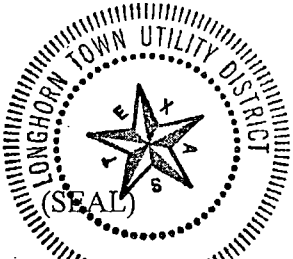
The meeting will be held on Thursday, June 2, 2022, at 12:00 p.m.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:


1. Public comments;
2. Approval of the minutes of the May 5, 2022, Board of Directors meeting;
3. Acceptance of Qualification Statements, Bonds, Oaths of Office and Affidavits of Current Director for Directors Crain, Swearingen and White;
4. Elections Not to Disclose Certain Information;
5. Election of officers of Board of Directors;
6. Approval of District Registration Form relative to election of Directors;
7. Engagement of auditor to audit the District's financial statements and prepare the District's audit report for fiscal year ending June 30, 2022;
8. Bookkeeper's Report, including financial and investment reports, and authorizing the payment of invoices presented;
9. Adoption of operating budget for fiscal year ending June 30, 2023;
10. Authorize completion, execution and filing with the Secretary of State of Voting System Annual Filing Form relative to District elections;
11. Tax Assessor-Collector Report, including authorizing the payment of invoices presented and the approval of moving accounts to the uncollectible roll, including:

 - (f) Submission of updated contact information and/or descriptive information regarding District facilities that qualify for critical load status to the County Office of Emergency Management, Public Utility Commission, and the Division of Emergency Management of the Governor, relative to compliance with §13.1396, Texas Water Code;
