- 1. Consideration of public comments (public comment shall be limited to 3 minutes per member of the public);

- 3. Tax Assessor/Collector's Report;

 - b. review irrigation usage report;
 - c. status of miscellaneous operation, repair and maintenance items, and take any necessary actions on same;
 - d. review proposals in connection with cleaning/painting of District fire hydrants and take any necessary actions on same; and
 - e. status of filing of Risk and Resilience Assessment Report and preparation of Emergency Response Plan pursuant to the federal American Water Infrastructure Act;
- 6. Engineer's Report, including:
 - a. status of Joint Wastewater Treatment Plant expansion project;
 - b. update on Joint Facilities maintenance and operation matters and take any necessary actions on same; and
 - c. consider request(s) for service and take action on same;
- 7. Website and related communications report, including review correspondence to the District email address and take any necessary actions on same;
- 8. Discuss and take any necessary actions in connection with District walking trails and recreational amenities;
- 9. Discuss and take necessary action in connection with communication between District and Harris County Municipal Utility District No. 365 in connection with shared facilities;
- 10. Review insurance proposals received from Arthur J. Gallagher & Co. and Harco Insurance Services and take any necessary actions on same;


