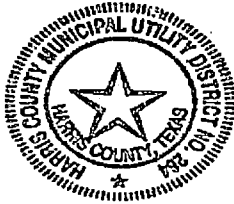
## NOTICE OF MEETING

  - b. authorize reimbursement of Association of Water Board Directors summer conference expenses.

5. Adopt Resolution Regarding Development Status for the 2024 Tax Year.
6. Operation of District facilities, billings, repairs, and maintenance, including:
  - a. water plant and distribution;
  - b. wastewater treatment, collection, and sampling; and
  - c. customer correspondence, requests, and inquiries.
7. Hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
8. Community Critical Information Notification System.
9. West Harris County Regional Water Authority matters.
10. Joint wastewater treatment plant matters.
11. Engineering matters, including:
  - a. authorize design, approve plans and specifications, authorize advertisement for bids, review bids and award contracts, approve pay estimates and change orders, and authorize final acceptance of District projects;
  - b. capital projects and improvement plan;
  - c. water plant repairs and improvements;
  - d. wastewater treatment plant repairs and improvements;
  - e. deeds, easements, consents to encroachment, requests for service or utility commitment letters; and
  - f. implementation of United States Environmental Protection Agency's Lead and Copper Rule revisions.
12. Water conservation matters.

14. District outreach and community relations.
15. District meeting schedule.


