

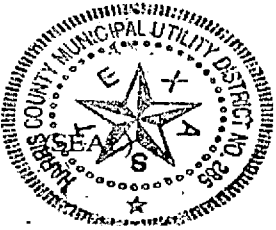
NOTICE OF MEETING

HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 285

The Board of Directors of Harris County Municipal Utility District No. 285 will hold a regular meeting on Monday, July 15, 2024, at 6:30 p.m., at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, Suite 2600, in the Neches Room, Houston, Texas 77027, to discuss and, if appropriate, act upon the following items:

1. Hear statements from the public and receive written questions.
2. Minutes of prior meetings.
3. Approve audit for fiscal year end March 31, 2024.
4. Financial and bookkeeping matters, including payment of the bills and review of investments.
5. Tax assessment and collections matters, including payment of tax bills, installment agreements, delinquent tax collections, sales tax reports, and requests for estimates of taxable value.
6. Adopt Resolution Regarding Development Status for 2024 Tax Year.
7. District website matters, including emergency alert/messaging services.
8. Security services matters, including report from Harris County Sheriff's Office.
9. Development in the District.
10. North Channel Water Authority report.
11. Detention facilities report, including proposals and task orders for additional maintenance.
12. Garbage collection and recycling services, including discuss garbage collection services contract.
13. Engineer's report on construction projects in the District, including the following:
  - a. authorize design of facilities in the service area;
  - b. approve plans and specifications and authorize advertisement for bids for construction of facilities in the service area;
  - c. review bids and award contracts for construction of facilities in the service area, including:
    - i. water plant no. 1 drainage improvements;
    - ii. lift station and storm water pump station to serve tract located off Wallisville Road east of Carpenters Landing; and
    - iii. waterline extension and force main to serve tract located off Wallisville Road east of Carpenters Landing.
  - d. approve pay estimates, time extensions, change orders, certificates of completion and final acceptance for projects in the service area, including:
    - i. clearing of the tract located off Wallisville Road east of Carpenters Landing; and

- ii. detention pond to serve tract located off Wallisville Road east of Carpenters Landing.
  - e. review and approve report on electricity consumption and energy efficiency measures and take any necessary action;
  - f. deeds, easements, plats, surveys, as-built certifications, appraisals, phase I environmental assessments, consents to encroachment, and utility commitment requests;
  - g. development of geographic information system; and
  - h. proposals for engineering services, including proposal for design of wastewater treatment plant conversion to bleach.
14. Update on annexation of 15.022-Acre Tract.
  15. Harris County Fresh Water Supply District No. 51 water plant rehabilitation and upgrade project.
  16. Operator's report, including:
    - a. operation, maintenance, and repair of District water, sanitary sewer, and storm drainage facilities;
    - b. sanitary sewer manhole survey;
    - c. customer billing and collection;
    - d. smart meter installation program;
    - e. wastewater treatment plant no. 1 conversion to liquid bleach system; and
    - f. hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
  17. Supplemental report on operation and maintenance of District facilities
  18. Discuss renewal of District's insurance policies.
  19. District meeting schedule.
