- 1. Public comment.
- 2. Approve minutes.
- 3. Security matters, including review Constable's report.
- 4. Houston Premium Outlets development, including Economic Development Agreement reimbursement payment.
- 5. Financial and bookkeeping matters, including payment of the bills and review of investments.
- 6. Review budget for fiscal year end December 31, 2023, including Regional Facilities Budget.
- 7. Tax assessment and collections matters, including:
 - delinquent tax collections, installment agreements, and payment of tax bills;
 - b. report on commercial businesses for the Strategic Partnership Agreement; and
 - c. review notice regarding the annual assessment for 2023, pursuant to the Property Assessed Clean Energy Act for inclusion in 2022 tax bills identified by Simon Property.
- 8. Discuss 2022 tax rate, set public hearing date, and authorize notice of public hearing regarding adoption of tax rate.

 - approve pay estimates, change orders, substantial completion, and final acceptance for the water plant improvements;
 - c. wastewater discharge permit renewal application, including request for re-rating of wastewater treatment plant; and
 - d. request from Harris County Improvement District No. 13 regarding sale of regional detention facility access property.
- 10. Operator's report on water, wastewater, and stormwater facilities, including:
 - a. discuss fuel adjustment request, and, if appropriate, approve amendment to Operating Services Agreement;
 - b. review Water Usage and Surcharge Report;
 - c. water plant no. 1 generator fuel regulator replacement and booster pump no. 5 repairs;
 - d. water plant no. 2 booster pump no. 1 motor replacement;

- e. wastewater treatment plant auto sampler replacement and drum screen repairs;
- f. wastewater treatment plant clarifier no. 2 gear drive repairs;
- g. wastewater treatment plant lift pump nos. 1, 3, and 4 repairs;
- h. well no. 6 communications line repairs;
- i. well no. 1 emergency repairs;
- j. water well no. 5 power supply investigation; and
- k. hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
- 11. Report from Stormwater Solutions regarding detention facility maintenance, including stormwater quality features and permits.
- 12. Update on regional detention facilities, including wildlife management matters, and security matters.
- 13. Fairfield Joint Operations Council.
