**The meeting will be held on Monday, November 22, 2021, at 12:00 P.M.**

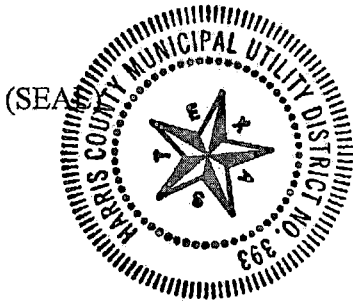
The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Public comments;
2. Review and approve minutes of the October 25, 2021, Board of Directors meeting;
3. Tax Assessor-Collector Report, including authorizing payment of invoices presented and approving moving of accounts to uncollectible roll;
4. Report on legal action taken by the District's delinquent tax collections attorney, including authorizing foreclosure proceedings, installment agreements, and the filing of proofs of claim;
5. Bookkeeper's Report, including financial investment reports and authorizing the payment of invoices presented;
6. Engineering Reports, including:
  - a. Authorizing, as appropriate, the design, advertisement for bids and/or award of construction contracts or concurrence in the award of contracts and approval of pay estimates and change orders for the construction of water, sanitary sewer and drainage facilities within the District, authorize related Developer Participation Agreement, Interlocal Cost Sharing Agreement or participation in 30% program with City of Houston, and authorize acceptance of Texas Ethics Commission Form 1295;
  - b. Acceptance of sites and/or easements and/or conveyances of facilities constructed or to be constructed for the District;
  - c. Status of acceptance by City of streets and storm sewers for maintenance;
  - d. Status of any necessary compliance with Chapter 191, Texas Natural Resources Code ("Antiquities Code") and take any action in connection therewith; and
  - e. Detention Pond Maintenance Report from Storm Water Solutions;
7. Developers' Reports, including status of proposed annexation of 52.5-acre tract;
8. Authorize attorney to file Eminent Domain Report with the Texas Comptroller of Public Accounts prior to February 1, 2022, pursuant to § 2206.154, Texas Government Code;

9. Matters related to Directors Election to be called for May 7, 2022, including (i) notification to Harris County officials that the District intends to participate in the joint election; (ii) publication of notice regarding accessible voting systems, and (iii) posting of Notice Regarding Candidate Filing Period;
10. Attorney's Report; and
11. Matters for possible placement on future agendas.
