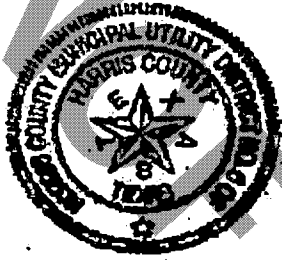
HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 6 OF HARRIS COUNTY, TEXAS

 - a. preparation and approval of plans and specifications, advertisement for bids, award of construction contracts, approve proposals, pay estimates, change orders, and final acceptance and direct engineer to notify insurance company of new facility for the following:
 - i. Waste Water Treatment Plant Improvements;
 - ii. Sanitary Sewer Rehabilitation, Phase II;
 - iii. Sidewalk Improvements for Carriage Lane playground;
 - b. consider requests for annexation or out of District service, including approve out-of-district service agreement, authorize notice of termination, and accept acknowledgment of out-of-district service agreement assignment;
 - c. deeds, easements, consents to encroachment, requests for service, and utility commitment letters; and
 - d. other engineering matters.
