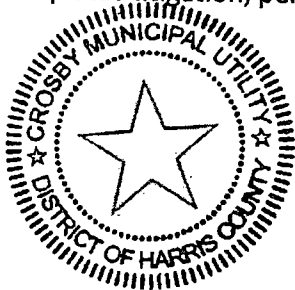

VI. Reconvene into regular session


VII. Consider and take necessary action on the result of the Executive Session
